The Town of Baltimore is updating its Local Hazard Mitigation Plan. The purpose of this planning effort is to protect life, property, economy, quality of life, and environment of the Baltimore Community from naturally occurring hazards and disasters. We are requesting input from the local community regarding experiences and concerns about weather related events and the potential risks and vulnerabilities to hazards, such as flooding, erosion, extreme temperatures, winter storms and drought.

The Town's Hazard Mitigation Planning Team will be holding a series of public meetings over the next few months during this planning process. This second meeting will be held at the Town Office on October 25<sup>th</sup> from 6:30pm to 7:30pm and conducted by the Mount Ascutney Regional Commission (MARC). The public is encouraged to attend and share their thoughts.
